Criminal Charges filed on Blaine Pedestrian Fatality from December 6, 2019

The driver involved in the car vs. pedestrian fatality crash from December 6, 2019 in the City of Blaine, has now been charged by criminal complaint. The driver involved has been identified as Matt Warren Hastreiter, age 42 of Lexington, MN. By criminal complaint, he is charged with criminal vehicular homicide (alcohol concentration of .08 or more). The victim has been identified as Sheryl Ann Miller, age 52 of Blaine, MN.

This case is still an active investigation by the Blaine Police Department, Minnesota State Patrol, Hennepin County Medical Examiner, and Anoka County Sheriff's Office. No further information will be provided at this time.

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Vehicular Homicide (Alcohol Concentration of .08 or More)

Minnesota Statute: 609.2112.1(a)(3)

Maximum Sentence: 0-10 Years and/or \$6,000.00 - \$20,000.00

Offense Level: Felony

Offense Date (on or about): 12/06/2019

Control #(ICR#): 19310817

Charge Description: On or about December 6, 2019, in the County of Anoka, Minnesota, MATT WARREN HASTREITER, did cause the death of a human being not constituting murder or manslaughter as a result of operating a motor vehicle while having an alcohol concentration of 0.08 or more.

STATEMENT OF PROBABLE CAUSE

On December 6, 2019, at approximately 6:02 a.m., the Blaine Police Department was dispatched to Naples Street just south of Lake Drive in the City of Blaine, County of Anoka, State of Minnesota, on a vehicle on pedestrian accident. Upon arrival at the scene, the police found S.A.M. (an adult female) lying in the roadway. S.A.M. was later pronounced dead. S.A.M. had been struck by a car that was still at the scene. The police spoke to the driver of the car that struck S.A.M., the defendant, Matt Warren Hastreiter (DOB: 3/29/77). The defendant told the police that he was driving on Naples Street when he hit something. The defendant stopped immediately and saw that he had hit the female. Upon speaking with the defendant, the police could smell a faint odor of alcohol. The defendant admitted that he had eight shots of vodka the night before, and three more shots of vodka this morning. The police then had the defendant perform some field sobriety tests. The defendant performed the one leg stand and the walk and turn, both of which he failed. The defendant was then given a PBT which registered a blood alcohol content of .117.

The Minnesota State Patrol conducted a crash reconstruction, and the results are still pending. The police did obtain a search warrant for a blood sample of the defendant, and the results are still pending. The police also spoke to another witness at the scene, who said that he saw the defendant driving the car that hit S.A.M.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
