The attention of the bidders is directed to know that the 2018 Edition of the Minnesota Department of Transportation "Standard Specifications for Construction" shall govern this project except as stated in the proposal. The attention of bidders is directed to Specification No. 1801 covering sub-letting or assigning portions of the contract. The wage rates for the project have been predetermined and are available in the Office of the County Engineer.
