<u>Eviction Related-</u> Writs of Recovery and Unlawful Detainers Posting Service Fee Lockout/Eviction	\$80 \$80 1 st person, \$10 each additional service \$110 per hour
<u>Mortgage Foreclosure-</u> Service Fee per person—3 attempts Each additional attempt at same address Judgment & Decree Posting 3 places (ACSO, Anoka County Courthouse, City Hall of City in which home is located) Conducting Sale **Outside Bidder Fee (for winning bidder)	\$80 \$25 \$80 \$80 \$80 \$100

<u>Commission on Executions</u> <i>(Percent based on gross amount collected, seized, or stipulated to by parties; or any settlement resulting from ANY action of the Anoka County Sheriff's Office to satisfy the Writ of Execution or Sheriff's Levy. This DOES NOT include Civil Deputy Time or service fee.)</i>	5% **
<u>Storage Fee</u> <i>For vehicles maintained by the Sheriff's Office while awaiting Sheriff Sale for Writs of Execution or other Civil Matters</i>	\$20
Execution Sales & Sheriff's Sales/Lien Sales	\$200** <i>(*plus Civil Deputy time if more than one hour)</i>
<u>Redemptions</u> Record Redemption Documents for Junior Lienholders <i>(Lien Holders, Judgment Holders, Intent to Redeem)</i> <i>Non- Sheriff Redemption</i>	\$250 \$100 \$20
Replevins, Attachments or Seizures	\$200** <i>(*plus Civil Deputy time if more than one hour)</i>
Replacement Certificate of Service (lost or damaged)	\$10
