<p><b>ONE of THESE</b></p>	<ol style="list-style-type: none"> <li>1. <b>MN Driver's License, Identification Card or Learner's Permit</b> - a valid Minnesota Driver's License, Identification Card, or Learner's Permit or a receipt that contains a current name and address</li> <li>2. <b>Prior Registration</b> - a valid registration under a different name or address in the same precinct</li> <li>3. <b>Notice of Late Registration</b> - with the voter's current name and address sent by Anoka County Elections</li> <li>4. <b>Tribal ID</b> - a tribal photo identification card with the voter's name, current address and signature</li> <li>5. <b>Voucher</b> - Several options may be used to vouch for a voter. Note: a voter who has been vouched for on election day may not vouch for an individual on that same election day.
